Dear Sir,

Reference your letter/application dated 07/02/2019 for issuance of new enlistment letter in Probationary Class (Civil/E&M) having tender limit up to Rs. 5,00,000/- (Five lacs only) The competent authority has approved your enlistment in Probationary Class.

Your enlistment is approved up to **31/03/2024** subject to the conditions accepted by you during which you shall have to complete successfully at least five works in five years of any amount in DJB to become eligible for further enlistment in class-V, on satisfactory completion of said number of works, your enlistment may be considered for enlistment in class-V depending upon your performance of the works and other requisite documents as per rule. Security deposit amounting to Rs. 50,000/- will be refunded thereafter. In case the contractor/firm is not able to secure works in DJB during the last block of 5 years, the applicant/firm stands removed from the list of probationary class of contractors in DJB and security deposit will not be refunded. However, the contractors enlisted in P-Category with DJB shall have to fulfill other statutory requirements of Govt. like e-tender code/password, registration with VAT authorities & Service Tax etc.

The Contractor/firm will have to deposit earnest money with each individual tender and security deposit will be recovered from their bills in accordance with the prevailing rules.

Clause 17.1 Restrictions for close relatives: CEO, All Members, All Directors, Jt. Directors, Secretary (DJB), All Assistant Commissioners, Dy. Directors, CWAs, ACWAs, Entire engineering cadre from JE to CE (both inclusive) and Entire Finance Cadre from Divisional Accountant and above, themselves and their close family members will not be allowed to be enlisted as DJB contractor in any class and will not be allowed to participate in the tenders of Delhi Jal Board during their tenure of service in DJB. For this purpose, definition of 'Close family member' shall include respective spouses, parents, children and children's spouses.

Clause 17.2. Restriction for near relatives: In addition to above contractors whose near relatives are in the finance cadre in the rank of Divisional Accountant and above or Engineering Officers between the grades of Junior Engineer and Chief Engineer (both inclusive) in the Delhi Jal Board will not be allowed to tender for works if the circle responsible for award and execution of contract is the one where the near relative is working or supervising. For this purpose near relatives shall include grandparents, grandchildren, brothers, sisters, uncles, aunts, cousins and their spouses and corresponding in-laws. For the sake of clarity, it is reiterated that close relatives (respective spouses, parents, children and children's spouses and the individual himself/herself) stand barred already as per clause 17.1. Any breach of this condition by the contractor/ firm shall render them liable to be removed from the approved list contractors of the Department.

The contractor/firm shall also intimate the change in their permanent address, if any, in advance or maximum within one month of such change along with acknowledgment of noting down of such change in address from the Bank, Income Tax, Sales Tax authorities etc. In case they fail to intimate such change to the department, the firm/contractor is liable to be removed from the approved list of contractors of DJB.

The contractor/firm shall not enter into any fresh partnership or modify the existing partnership/sole proprietorship/status of the firm without the prior approval of the department, in case they wish to enter into any partnership, they must intimate in advance the full details of the new partners, their relationship with existing partners, if any, along with draft of the proposed partnership deed. Any departure from this will render the contractor liable to be removed from the approved list of contractors of the department. The contractor/firm will have to abide by the existing term and conditions of the contract as may be amended from time to time.

It may be noted that any documents submitted by the applicant contractor if found to be false at any stage even after enlistment, the enlistment authority reserves the right to cancel the enlistment of the applicant /firm without serving any notice. Any departure from above conditions will render the contractors/firm liable to be removed from the approved list of contractors.

It may be noted that the contractor shall apply for enlistment in higher class before the expiry of his enlistment along with requisite documents as required for enlistment.
